

## NEIGHBORHOOD NEWS BITS

### • UNIVERSITY OF WESTERN STATES MOVING INTO THE MSNA NEIGHBORHOOD

University of Western States (UWS) is relocating its campus to the former corporate headquarters of Banfield Pet Hospital, at 82nd Avenue and NE Tillamook Street. The new campus showcases a modern health care facility designed to fulfill patient needs and provide exceptional opportunities for clinical training. Founded in 1904, UWS offers health science and health care professions education in chiropractic medicine, human nutrition and functional medicine, sports medicine, diagnostic imaging, sport and performance psychology, and clinical mental health counseling. UWS currently employs more than 150 on-campus employees, enrolls more than 1,200 students online and on-campus, and continues to grow and expand. UWS selected the 82nd Avenue facility for a variety of reasons, including closer proximity to inner Northeast Portland. Welcome to the neighborhood!

### • SPEED LIMIT CHANGES ON RESIDENTIAL STREETS

In support of the City's *Vision Zero* goal to eliminate traffic deaths and serious injuries, the speed limits on a number of city streets are being reduced. As people travel faster, the risk of death or serious injury rises dramatically. A person walking struck by a person driving 40 mph is **eight times more likely to die** than one struck by a person driving at 20 mph. The speed limit in residential areas of Portland has been set at 20 MPH. ### • PORTLAND PARKS FOUNDATION GRANTS PROGRAM

Portland Parks Foundation offers a small grants program to support community organizations working to create or care for public parks and park programs, community gardens, and natural areas. The program is founded on a generous bequest from Nancy Hebb Freeman, an artist, hiker, and lover of Portland parks. These grant awards, in amounts usually ranging from \$250 to \$2,500, are awarded in two cycles each year (March and September). To apply, please submit a cover sheet, a list of governing body members along with their email and phone contacts, 501(c)(3) tax determination letter (if applicable), letter of project approval from PP&R or associated agency (if applicable), and a short letter (1,000 words maximum—approximately 2 pages) that addresses need, timetable, how your project aligns with PPF's mission, community support, management, cost, and measurable results. ### • HOMELESSNESS AND ONE POINT OF CONTACT

There are two ways to report a campsite: a form on the City of Portland's webpage ([www.portlandoregon.gov/campsites](http://www.portlandoregon.gov/campsites)) or online at PDXreporter.org. Not all reports will result in immediate action by the City, as notification must be posted at a camp before cleanup. Before a cleanup can occur, the City will work to move the camp, and will do so in the least traumatic, most compassionate manner possible.
